### WHMIS – AN INTRODUCTION

All employers in Canada are required, by law, to provide WHMIS (Workplace Hazardous Materials Information System) training to workers who work with, or in proximity to controlled products. Workers may be required to work with hazardous materials that are new to the workplace, or previously installed - requiring repair, maintenance or removal.

Handling hazardous materials requires effective handling procedures, personal protective equipment and most importantly, training. Training must be provided: to new employees; when new products arrive in the workplace; and **at least annually, as a review.**
